




## **New Year New Location**

- \* Set the date for the next quarterly meeting for March 26, 2022.

# **Georgetown Tribal Council**December 3, 2021 Quarterly Meeting

The Georgetown Tribal Council, the governing body of the Native Village of Georgetown, met on Friday, December 3rd, 2021 for their quarterly meeting. Council Members that attended the meeting were Traci Maczynski, Gary Fredericks, Valerie Dudley, and David Kutch, and Stacy Turner.

### During the meeting the Council:

- \* Approved the meeting minutes from the last quarterly meeting on September 18, 2021
- \* Approved the agenda after amending the agenda
- \* Reviewed the Administrative reports from the Tribal Administrator and the staff.
- \* Received updates and reports from the Environmental Committee, Land Committee, Enrollment Committee, Policy Committee, Community Building Committee, and the Pre-audit Committee.

#### **Old Business**

- \* Received an update on the Tribal Liaison position that was briefly filled and what steps are being taken to fill the position.
- \* Was updated on the vacant youth position on the Environmental Committee and was notified that the committee is still seeking a replacement to fill the position.
- \* Approved the members for the Environmental Committee
- \* Council Member, David Kutch, gave an update from the AVCP Annual Convention. He talked about the difficulties about making quorum for the virtual event. AVCP talked about the roughly \$40 million in CARES aid. Administration was directed to follow up with AVCP on how the money will be used.
- \* Received and update from the Tribal Administrator on the Alaska Tribal Spectrum's Broadband plan noting that the only update from them was that they were seeking more federal funds.
- \* Had questions for the Tribal Administrator regarding the status of the office move that were not covered in his report.

#### **New Business**

- \*Voted to approve the two applications for membership that were reviewed by the Enrollment Commitee.
- \*There was discussion on budget approval policy and the Tribal Administrator was asked to prepare a draft policy for the next Policy Committee meeting.
- \* Reviewed a presentation from Tribal Administrator, Adrian Lecornu, on the results from the ARP survey that went out to members. The Council instructed Administration to pursue a vocational training program for members and to look into a food voucher/reimbursement program for members.
- \* Approved having a legal firm on retainer to review policy and documents for ARP program and made a selection from the options presented at the meeting.
